# ELECTRONIC SERVICE RECORDS

Starting this month we will cover some of the ins and outs of your new electronic service record. It is the Sailor's responsibility to maintain this document; however, not everybody knows what to look for, or how it may affect their future plans (like the CPO Boards.) We begin with a short Q&A session with PSC(SW/AW) Arana...

# Q: What has happened to our hard Copy Service Records?

A: All hard copy service records were digitally scanned to create individual Electronic Service Records and returned to the member.

# Q: How do I know if my Electronic Service Record is up to date?

A: Members may now view their Electronic Service Record/OMPF(Official Military Personnel File)via BOL(BUPERS Online).

#### Q: Who else has access to my Electronic Service Record?

A: PSD's and some CSD's have OMPF access to view anyone's Electronic Service Record.

#### Q: Can my command be granted the same access to view ESR's?

A: No, at this time access is limited to local PSD's/CSD's.

# Q: Who should I contact if I notice something is missing from my ESR?

A: You should first ask your LPO and or LCPO to see if it is something that should go in your ESR.

#### Q: I received an award and it is not reflecting in my ESR, what should I do.

A: Bring in a copy of your citation to CSD and we will mail it for you.

## Q: I just came into the Navy, who can help me get access to my ESR?

A: Your LPO and or LCPO whom already have access can assist you with setting up your BOL. ❖



# **Three House Keeping Tips for your Career**

Your ESR (Electronic Service Record) is very important. The ESR is one of the few resources the Navy has in place for your military and personal information. Your ESR's can affect pay, benefits, and board results. It is every Sailors responsibility to update and verify the content of your ESR. A Sailor should be verifying the content of their ESR at least once a quarter. Common ESR errors are missing qualifications, incorrect page 2, and missing evaluations. You should also keep a paper copy of all the awards, evaluations, and qualifications you receive, this will allow you to make updating missing information easier.

Who hasn't used the Career Management System (CMS/ID) to negotiate orders? The answer should be no one, as it's a requirement to get your orders to your follow on duty station. What most people don't know is before you go into your nine month negotiation window the detailers would like you to log into CMS and update your duty preferences. This enables the detailer to try and fit his needs to the areas you would prefer to go. The site now has a preference score that show the detailer how compatible your duty preference is to the orders they are looking at. Every Sailor should update this





With Perform to Serve (PTS) looming over a vast majority of the enlisted population's head, every Sailor should be doing everything in their power to make themselves competitive. One item over looked is a person's ASVAB score. If a Sailor does not think about this before their PTS window then it is too late. The Navy has stream lined the course to retake your ASVAB, it is now an online course tailored to your needs. Once you get the course completion certificate you are eligible to retake your ASVAB. Be warned though that your new score whether it is better or worse, becomes your current score. Sailors should retake their ASVAB score well in advance of their PTS window so they can be prepared for the possibility of having to convert to stay Navy. # Spray-on Protective Coating Wins "R&D 100" Award

ARLINGTON, Va. (NNS) -- R&D Magazine honored an Office of Naval Research (ONR) scientist with a 2011 "R&D 100" award Oct. 13 for the development of a revolutionary coating material that is blast-and fire-resistant.

The special high-tech surface technology, HybridSil Fire/Blast, acts like a force field that surrounds and protects any type of surface, making it blast-ballistic- and fire-resistant.

"You can take an existing material and change it completely to make it more useful for the warfighter," said award recipient Dr. Roshdy George S. Barsoum, ONR's manager, Explosion-Resistant Coating, Ships and Engineering Systems Division. "Receiving this award is recognition that we are developing something that the warfighter can really use and exploit."

The coating is sprayed onto surfaces just like paint, with minimal surface preparation. It is applied in variable thicknesses: less for fireproofing and more for blast-resistance. But the tricky part is that the law of diminishing returns is at work; at some point, the more you apply, the less effective it becomes. Determining the appropriate amount for each surface and user need is complex, Barsoum said.

The Navy is particularly interested in the material's fire-resistant properties, since fires, along with floods, present the greatest threats on a ship or submarine. The Army and Air Force have also been investigating its use to protect buildings against vehicle-borne explosive devices.

The coating was developed with industry partner NanoSonic Inc, and the cost per gallon is equivalent to premium house paint. It can be used on new and old materials alike, making it easy to apply to existing ships or vehicles.

The research into this coating began after the bombing of USS Cole (DDG 67) Oct. 12, 2000. The Navy wanted to find new ways of protecting ships, including coatings and polymers that could shield against explosions and fire. The research took off after 9/11, and the new defensive coating was applied to the rebuilt sections of the Pentagon.

According to R&D Magazine's website, the R&D 100 awards identify and celebrate the top high-technology products of the year, spanning industry, academia and government-sponsored research. Winning products include sophisticated testing equipment, innovative new materials, chemistry breakthroughs, biomedical products, consumer items and high-energy physics.

ONR provides the science and technology necessary to maintain the Navy and Marine Corps' technological advantage. Through its affiliates, ONR is a leader in science and technology with engagement in 50 states, 70 countries, 1,035 institutions of higher learning and 914 industry partners. ONR employs approximately 1,400 people, comprising uniformed, civilian and contract personnel, with additional employees at the Naval Research Lab in Washington, D.C. .

Photocopying Of Military ID Cards And CAC Cards Prohibited

WASHINGTON -- Commander, Navy Installations Command issued an announcement reminding all personnel that the photocopying of military identification cards and common access cards (CAC) is strictly prohibited, Nov. 1.

There have been recent incidents reported of commercial establishments photocopying U.S. government identification to verify military affiliation or provide government rates for service. These incidents are a violation of Title 18, U.S. Code, Part I, Chapter 33, Section 701 and are punishable by fine and/or imprisonment.

Although commercial establishments may request to see military/government identification, they may not photocopy or duplicate it in any way. Many military personnel and commercial establishments are unaware of the prohibition and the reasons it exists, which results in this being a fairly common practice.

Because of the access the cards grant, criminal elements and terrorist organizations place obtaining U.S. government identifications at a premium when planning acts against the U.S. military. If a copied military or government identification fell into the wrong hands, it could spell disaster for the Armed Forces and the nation.

Unfortunately, there are no safeguards in place to prevent a counterfeit military/government identification card from being produced based on a photocopy provided to a commercial establishment. For this reason, personnel are requested to remain vigilant in ensuring they do not allow anyone to photocopy their identification cards.

CNIC recommends that all personnel, both military and civilian, provide a state drivers license or other form of photo identification to be photocopied when there is a request for such information by a commercial establishment.



# MISHAP SUMMARIES (COMPILED FROM THE NAVY SAFETY CENTER)

At an admin support unit in the Middle East, a MA3 was standing in the harbor patrol compound near a guard shack, possibly minding his own business. At this point, the mishap narrative shifts into first person. "I heard people shouting behind me to move," the Sailor reported.

He had several options. One, ignore the warnings. Two, wonder about them, but stay put. Three, make tracks and find out later why folks were yelling at him.

He selected option two. "Something struck me in the upper part of my back and pushed me forward," he said. "I turned around to see what had struck me. It was a light pole that had fallen," thanks to the fact that it had "disintegrated" at ground level.

EXPLORER NUMBER TWO FIGURED HE COULD CLIMB DOWN TO HIS FALLEN COMRADE. AT THIS POINT, HAD HE ASKED ME, I WOULD HAVE SAID, "I'M POSITIVE YOU CAN GET DOWN TO HIM, BUT THEN WHAT? YOU KNOW THE OLD SAYING, 'WHAT GOES UP, MUST COME DOWN'? WELL, THE OPPOSITE DOESN'T HOLD." BUT HE DIDN'T ASK ME, HE JUST CLAMBERED/HIKED/SLID DOWN. AND THEN, OF COURSE, BOTH OF THEM WERE TRAPPED, WITH LOOSE SHALE AND MUD ABOVE THEM AND A CLIFF BELOW, AND JUST TO MAKE THINGS EVEN MORE INTERESTING, A TEMPERATURE OF 32 DEGREES.

SO THEY CALLED THEIR COMMAND, AND A HELICOPTER HAD TO COME PICK THEM UP. GLAD THEY HAD A SIGNAL, AND GLAD A HELO WAS HANDY. NEITHER OF THESE WOULD SEEM TO BE GUARANTEED. IT IS DOUBTFUL THEY WOULD HAVE SURVIVED THE NIGHT.

Naval Observatory Flagstaff Station (NOFS) in Arizona has Mexican Spotted Owls, Who Knew?

Did you know that the NAFEC environmental team also serves the Naval Observatory Flagstaff Station (NOFS) in Arizona? NOFS mission is to make, analyze, and interpret dark sky observations to fulfill the mission of the U.S. Naval Observatory.

Mexican Spotted Owls are a threatened species that populate the NOFS region. The Mexican Spotted Owls are a sub species of Spotted Owl. Mexican Spotted Owls are scattered in parts of Utah, Colorado, Arizona, New Mexico, Western Texas, and Mexico. These owls are about 17 inches in height and about 21 ounces in weight.

Since the Mexican Spotted Owl is a "threatened" species, it is protected under the provisions of the federal Endangered Species Act and the federal Migratory Bird Treaty Act. The federal Endangered Species Act defines a threatened species as one which is "likely to become an endangered species within the foreseeable future throughout all or a significant portion of its range." An endangered species is an animal in danger of becoming extinct. The federal Migratory Bird Treaty Act makes it s unlawful to hunt capture, kill, or harass almost every bird in North America. Violations of these laws can lead to significant penalties.

One mission of the environmental team is to mitigate project-related impacts to threatened and endangered species as required by the provisions of the Endangered Species Act. Their job is mission-critical because any project carried out by a federal agency with potential to impact endangered or threatened species requires consultation with the U. S. Fish and Wildlife Service to ensure that projects do not put these sensitive creatures at risk. Depending on the type of construction, typical mitigation could include; completing projects outside of breeding season or a required education program for construction personnel.

Overall, the environmental team at NAFEC has their hands full with the Mexican Spotted Owl. Here in El Centro, there are also two additional species that require extensive oversight. These two species are the Burrowing Owls and the Flat-tailed Horned Lizard. Their stories will be detailed in future articles. ❖

# What's Up, Navy Doc?

"Moles: The Skin Kind Are Not Always Kind to the Skin"

Everyone has them. Moles—those brown or black spots on your skin—are mostly benign, not harmful. Yet, in some cases, moles can develop into something much more serious, like skin cancer. How are you supposed to figure out which is which?

#### WHAT ARE MOLES?

Moles are growths on the skin that occur when the cells—melanocytes—that make the skin color—pigment—grow in a cluster. Moles are very common, with most occurring in early childhood and during the first 30 years of a person's life. It is not unusual to have anywhere from 10 to 40 moles in adulthood. As a person ages, the moles might change—they might become slightly raised or lighter in color or not change at all, while still others might disappear completely. Moles can appear anywhere on the skin, from the top of the head to the bottoms of the feet.

#### A BENIGN-NOT HARMFUL-MOLE HAS THE FOLLOWING TRAITS:

- It is one color—tan, brown, black, or skin-colored.
- · Round in shape.
- Flat or slightly raised.
- Looks the same every month.

#### MELANOMA—THE DEADLIEST FORM OF SKIN CANCER—CAN OCCUR AS A MOLE!

It can develop even from a small existing mole or it can develop on its own. It occurs when the melanocytes become abnormal and grow uncontrollably. Unfortunately, they can invade the surrounding tissue and kill the normal cells.

# **RISK FACTORS FOR MELANOMA:**

- Personal history of melanoma.
- Family history of melanoma.
- Many normal moles (more than 50).
- Extensive exposure to the sun.
- History of severe, blistering sunburns.
- Freckles.
- Fair Skin.

The following "ABCDE's" are important signs that a mole could be melanoma:

- **A = Asymmetry**. One half of the mole is not the same as the other half. Think of it like an egg omelet—if you flipped it over in the pan, would it look the same?
- B = Border. The mole's borders or edges are irregular or not well-defined.
- C = Color. The mole's color is not the same all over.
- **D = Diameter**. The mole's diameter is larger than a pencil eraser.
- **E = Evolution**. The mole changes in color, size or appearance over time.

# **HEALTH TIPS:**

- If your moles are changing, itching or bleeding, make an appointment with your PCM.
- Perform self-examinations of your skin on a regular basis. Examine the scalp under your hair and on all parts of your body, including between your toes and the bottoms of your feet. Enlist a family member or friend to look at the more difficult areas of your body to see (your back and the backsides of your head, neck and legs).
- Protect your skin from the sun. Wear SPF 30 or greater to get the best protection from the UVA and UVB sunrays. Wear sunglasses with UV protection.

# REMEMBER:

- The roles of moles are being akin to your skin. Most are good while some are bad; know which is which so you won't be had. And please don't wait and be too late.
- If you have any concerns or questions, I strongly urge you to see your primary care provider immediately.

#### BE KIND TO YOUR SKIN. GENERALLY, IT WILL BE KIND TO YOU.

#### Getting to know "Flu" the Foe...

Influenza (the flu) is a contagious respiratory illness caused by <u>influenza viruses</u>. It can cause mild to severe illness, and at times can lead to death. Some people, such as older people, young children, and people with certain health conditions, are at high risk for serious flu complications. The best way to prevent the flu is by getting **vaccinated** each year.

The 2011-2012 flu vaccine will protect against the three influenza viruses that research indicates will be most common during the season. This includes an influenza A (H1N1) virus, an influenza A (H3N2) virus, and an influenza B virus.

What are the two main types of influenza (flu) virus? Types A and B. The influenza A and B viruses that routinely spread in people (human influenza viruses) are responsible for seasonal flu epidemics each year. Influenza A viruses can be broken down into sub-types depending on the genes that make up the surface proteins. Over the course of a flu season, different types (A & B) and subtypes (influenza A) of influenza circulate and cause illness.

What are ways to keep flu away? Wash your hands frequently with soap and water, or clean with alcohol-based hand cleaner. Avoid touching your eyes, nose or mouth. Avoid exposure to sick people if possible. Get vaccinated!

Vaccination is highly recommended for these groups: Children 6-9 months old, people 50 years old and older, pregnant women, anyone with chronic medical conditions that increase their risk of complications from flu, anyone with immunosuppressant, caregivers of children less than 5 years old, or of people with chronic medical conditions, healthcare workers and emergency services personnel, residents of nursing homes and other long-term care facilities, people that are morbidly obese.

What do I do if I have the flu? Stay home until at least 24 hours after your fever is gone without the use of fever-reducing medicines. If employed, notify your supervisor. Cover your cough or sneeze with a tissue (proper cough etiquette), and then put your used tissue in the waste basket. If you don't have a tissue, then cough or sneeze into your upper sleeve or elbow, not your hands. Clean your hands with soap and water or hand sanitizer after coughing or sneezing. Wear a mask when around other people. Contact your medical provider within 48 hours of symptom onset if you have conditions that increase your risk for complications. Blood disorders (including sickle cell disease)

#### Can a flu shot give you the flu?

No, a flu shot cannot cause flu illness. The influenza viruses contained in a flu shot are inactivated (killed), which means they cannot cause infection. Flu vaccine manufacturers kill the viruses used in the vaccine during the process of making vaccine, and batches of flu vaccine are tested to make sure they are safe. In randomized, blinded studies, where some people get flu shots and others get saltwater shots, the only differences in symptoms was increased soreness in the arm and redness at the injection site among people who got the flu shot. There were no differences in terms of body aches, fever, cough, runny nose or sore throat.

# Why do some people not feel well after getting the seasonal flu shot?

The most common side effect of seasonal flu shots in adults has been soreness at the spot where the shot was given, which usually lasts less than two days. The soreness is often caused by a person's immune system making protective antibodies to the killed viruses in the vaccine. These antibodies are what allow the body to fight against flu. The needle stick may also cause some soreness at the injection site. According to the Advisory Committee on Immunization Practices (ACIP), rare symptoms include fever, muscle pain, and feelings of discomfort or weakness. If these problems occur, they are very uncommon and usually begin soon after the shot and last 1-2 days.

Seek medical care immediately if you or your children have any of these warning signs: Fast breathing or difficulty breathing, bluish skin color, not drinking enough fluids, not waking up or not interacting, being so irritable that the child does not want to be held, flulike symptoms improve but then return with fever and worse cough, fever with a rash, pain or pressure in the chest or abdomen, sudden dizziness, confusion.

# ARTICLE 31(B)

Each time I give training in my office to prospective CDOs, I ask them what is Article 31(b)? We've all seen "Law & Order" and other law enforcement focused tv shows and movies and heard the typical refrain when someone is being arrested, "You have the right to remain silent..." It's usually as the tough cop that just sprinted after the bad guy over several city blocks is removing one hand at a time from the back of the suspect's head and handcuffing them together.

Are these "Miranda" rights the same in the military? The answer to that is a typical lawyer's response, yes and no. As a service member in the military, yes you have the same 5<sup>th</sup> amendment rights as all citizens in the United States. That being, that you cannot be forced to incriminate yourself. By 5<sup>th</sup> amendment right I mean from the Bill of Rights that was enacted with the Constitution in 1787. That is what this Miranda warning is designed to do, inform citizens of this right so they don't unintentionally incriminate themselves.

So yes, in the military you also have a 5<sup>th</sup> amendment right not to incriminate yourself, though it might not always feel that way given the sometimes coercive feel of chain of command questioning. Anyone who has ever been on the receiving end of some chain of command frustration will admit that though they are told answering the question is voluntary it may feel more like a "volun-told" situation.

The Manual for Courts Martial (MCM) and the UCMJ create an intricate and truly fascinating military justice structure; one that affords unprecedented rights and protections to military service members while still ensuring that good order and discipline and military operational readiness are preserved.

The UCMJ (and the MCM) was created by act of Congress in 1950, signed into law by President Harry S. Truman and went into effect in May 1951. In that very first UCMJ is Article 31. From the first time the military codified rules related to court martial and disciplinary proceedings is an article that procedurally ensures members are advised of their 5<sup>th</sup> amendment rights against self-incrimination.

Article 31 was truly ahead of its time. There was no analog in the civilian criminal system. It wasn't until 1966 in a 5-4 decision did the Supreme Court decide the Miranda v. Arizona case thus codifying Miranda warnings. And where did the Supreme Court turn? They turned to the very first Manual for Courts Martial from 1951. In the decision you will find a footnote referring back to Article 31 of the UCMJ as providing the basis for the Miranda warning.

For those of you keen on the legal intricacies, you will note that Miranda warnings are only required when the accused is being interrogated and is in custody. The definition of those terms has been repeatedly litigated and modified. For example, a witness who is not suspected of a crime would merely be interviewed, not interrogated so no Miranda warnings are given. And a person of interest invited to the police station and free to leave when he pleased would not be in custody for purposes of Miranda.

The primary issue identifying those two requirements is the coercive nature of both interrogation and custody (often shorted to "custodial interrogation"). That's exactly what Article 31 was designed to guard against—the inherently coercive nature of answering questions up the chain of command. Generally, when a military superior asks a question it must be answered and answered truthfully. Questions about a crime sailors are suspect of are separate and different. Questions involving conduct that may incriminate a sailor (and thus potentially violated his 5<sup>th</sup> amendment rights) do not have to be answered. Remember, you have to choose of your own accord to incriminate yourself—you cannot be forced either physically or constructively into it.

So what's different between Miranda and Article 31? A few things but most notably is that Article 31 requires that anyone who questions someone they suspect of an offense under the UCMJ to notify that person of the offense they suspect them of. Miranda rights do not require law enforcement inform the accused of the crime they suspect. So if you're reading Article 31(b) rights to someone you suspect of a crime, don't watch Law & Order before and expect to be prepared. Look up Article 31 in the UCMJ, Google an Article 31(b) form online and call your friendly JAG! ❖

After all, with a history as unique as the one the base has, is it possible that astronauts, aviation legends and even movie stars lived and flew here? The short answer is yes, and here are three examples to prove it. The Old Goats managed to find evidence of three well known personalities who visited here during World War II. Also, thanks to some investigative work by the PAO Michelle Dee, you can see one of the apron slabs by Hangar 7 was poured during "D-Day." Who knew?



Tyrone Power, an R5C copilot, was assigned to VMR-352 and was based at El Centro from October 1944 to January 1945. He took part in the action at Iwo Jima and Okinawa flying supplies and evacuating the wounded.

John Glenn arrived in El Centro on July 4, 1943. He learned how to fly the F4F Wildcat and got quite a bit of gunnery practice in on the local ranges. He and his squadron departed on February 5, 1444 to head towards their next assignment on the Marshall Islands.



Charles Lindberg was not an actual military pilot. However, he did ferry aircraft and instructed pilots in flight operations. In 1943 he visited El Centro and delivered a new version, giving presentations on recent upgrades designed to make landing less problematic.

Until next month keep your eyes wide open, and your hearing at max capacity. You never know when you might be witnessing history in the making. Also, keep a weather eye out for all those signs in the valley; they may point out a nifty bit of news! ❖

#### **DEFY Kids Commemorate Red Ribbon Week**

In 1985, Sol Green was a sixth grader, attending school in Guadalajara, Mexico. One day, the principal told the class that her friend, Enrique, would not be returning to school. His father was missing and his family was forced to leave for their own safety.

Twenty-five years later, Green, now a military spouse aboard Joint Base Pearl Harbor-Hickam, came to Marine Corps Base Hawaii for her son's flag football game.

Stopping by the Marine Corps Exchange Marine Mart, she received a pink flyer telling a story about her classmate's father Enrique Camarena Sr., a Drug Enforcement Administration agent who died in the line of duty.

"I was just kind of shocked," Green said. "It's been so many years since I've seen him."

In honor of Red Ribbon Week last Saturday, more than a dozen Drug Education for Youth participants passed out red ribbon pins, dog tags, and other small tokens of remembrance while telling Enrique Camarena Sr.'s story to visitors at the Marine mart.

"You can read something about Enrique, you can talk about Enrique, but it's a new feeling to meet someone who knew Enrique," said Leroy Contee, DEFY and Drug Abuse Resistance Education coordinator at the Military Police Department, who was excited to meet Green. "To be 3,000 miles away and find a group of people you don't know [commemorating someone you know]. That has got to be overwhelming."

Observed annually during October, Red Ribbon Week began in 1986, one year after the kidnapping, torture and murder of the elder Camarena. While working undercover in Chihuahua, Mexico, Camarena helped expose and cease many narcotics operations, which ultimately cost him his life, at the hands of the drug cartels. This month, he is remembered in many places across the nation, including MCB Hawaii.

"It's another side of drugs they don't get to see in school," said Petty Officer 2nd Class Derek Miles, a DEFY mentor. Miles, a DEFY mentor, supported the children as they approached visitors outside the Marine mart.

"You never know the age kids will try a cigarette or be introduced to drugs for the first time," Miles said. "This is a good way to catch them early." Cameron Rowe, a DEFY participant, said she doesn't like that people become addicted to and die from drugs. As she passed out flyers and items for Red Ribbon Week, Rowe thanked passersby for staying drug free. "I think a lot of people understand that drugs can harm you," Rowe said.

In 1993, the Secretary of the Navy's Drug Demand Reduction Task Force began pilot DEFY programs, and now hosts programs nationwide and worldwide to Department of Defense dependents ages 9 to 12. According to the Navy Personnel Command website, DEFY described this particular age range as "at risk to become involved in substance abuse, gangs and crime."

Red Ribbon Week is more significant and special for Green, now that she knows it's in honor of her classmate's father. To this day, she does not know her friend's whereabouts, though she and her classmates still think about him. Although Red Ribbon Week commemorates a solemn occasion, for Green, it also helps bring back good memories of an old friend. "It would have been great to keep in touch," Green said.

For the purpose of this article I went on a mini-tour of the city's parks to give you a quick glimpse of what is off base and out there for your free entertainment. I only took a quick look at the parks and while in some of them there isn't much to look at, this article is for you to take one person's curiosity and develop it a little more to fit your purposes. I visited all of these parks on the same day in succession for the baseline, kind of like an experiment. I visited all the town parks on the map, except for the golf course because if you're a golfer that is why you'll go there. There were a couple of parks that there really was no reason to have them on the map yet! There is on one the map called Lotus Park and one at Clark and Manuel Ortiz (no name) and they are at the present time just empty lots. There may be future plans for those areas, but as of yet they are bare.

For this and any future articles I write about Off base and into the Community you will be able to of course look on websites of whatever your curiosity might be. If you are eager for camping or mountain biking, you will probably do a quick search via your favorite search engine. I do that too! Mostly to disprove misnomers and popular belief that there is nothing to do here! In future editions I hope to change your opinion about that! My other and favorite resource is a map of El Centro/Imperial/Calexico that you can find and is pretty cheap. I found mine at K-mart, and if they have not replenished the stock you can find it on the web by searching for 'The Thomas Guide' for about \$5.00, a great investment! Much easier than getting lost, having bad directions, a poorly sketched map, or driving onto a street that you thought would lead you to somewhere, but leads you only to a dead end. I've done all of those!

The first and probably the best park in town was Bucklin Park. The play ground equipment is fairly new and mostly plastic, as was most of the equipment in all the parks so you don't have to worry about too many splinters and I won't repeat myself on that topic. There are plenty of restrooms. There is a lot of space for gatherings that you might have for a club, birthday party, or church gathering under shade structures with BBQ grills. There are a lot of trees to relax under, great walking paths and a pond with a couple fountains. The pond also has ducks to feed. The water is not all that clear, but you can't swim there anyway!

Stark Field Park has a couple of baseball fields so if you're out to just hit the ball around or play a little catch this is a pretty nice park. Gomez Park is kind of hidden and you can't see it form the street because it is behind the firehouse. Mcgee Park was being used for kid's football, so at the time I went there it was busy at least on the field. The playground equipment looked really new and there were different sections for varying ages of kids.

Adams Park is a long strip of land with streets cutting through a couple of sections, so watch the kids id you use this park. It is also next to a busy highway 86. There are only a couple of shade structures and I did not notice any grills, but there was an event going on, so rather than intrude I just took notice of what I could. There is no parking lot, you have to park along the street.

Swarthout Park was the second best park in my pick of parks. There are baseball and, soccer fields, basketball hoops and playground equipment. Plenty of shade structures with grills, restrooms, and lots of parking! This park was not being used and is a little further out and harder to get to but definitely worth going to!

Fraiser Field only had baseball fields, but has plenty of parking.

Carlos Aguilar Park was a little small and looks a little rundown. The facilities are limited and there are few shade structures and grills. The playground equipment looks good and there is a baseball field, soccer field, and basketball hoops.

Debbie Pitman Park was completely locked up and for you to gain entry to this one you'll have to request permission and file and application. 

#### Battle Field 3

If you want to know anything about the single-player campaign of Battlefield 3, then you came to the wrong place. Since its release on 25 October, 10's of thousands of gamers have flooded EA on line's servers for a chance to wage war in one of the largest and most versatile arenas to ever grace our respective screens.

Although the console is plagued with frequent technical problems, which can frustrate even the most patient of saints, the fun factor for any fan of FPS game play more than makes up for it. Whether choosing the assault classes to heal and revive comrades, going engineer for repairing or doing damage to any vehicle on the map, using the support class to drop ammo or playing recon to snipe and reveal enemies on the map, there is a class for everyone to enjoy. There are two main modes to play besides the obvious team death match.

In the Rush mode, teams take turns attacking and defending bomb sites with a limited number of respawns. If the site is destroyed then the map enlarges and new sites appear. In Conquest game mode both teams vie over set areas of the map in a sort of King of the Hill game style. While some of the maps are smaller with only infantry fighting in close quarter street battles, many of the maps are enormous and require lightly armored vehicles, tanks, helicopters and jets to traverse and fight in.

The Xbox and PS3 graphics are somewhat lacking in comparison to the PC. Also, while the PC allows up to 64 players to battle it out on huge landscapes, the Xbox and ps3 have a cap of 24 players. Since its release, the Xbox360 has seen daily system freezes and game-kicks right in the middle of a session. Despite all its faults, Battlefield 3 still delivers some of the most fun moments I've experienced in online war. �

# **DoD: Tuition Assistance Safe for Now**

WASHINGTON -- Although no changes to the tuition assistance policy will be made in the near term, defense officials stated the tuition assistance program will be considered as part of the holistic review of the military compensation package.

Current policy provides eligible service members up to \$4,500 in tuition assistance. The Defense Department will pay up to \$250 per semester hour for both undergraduate and graduate studies.

"The department, in consultation with the military service departments, is doing a thorough review of all the benefits included in the military compensation package," said Jo Ann Rooney, principal deputy undersecretary of defense, personnel and readiness.

"Our goal is that any announcements about changes to existing policies affecting service members' benefits and compensation will be made after the comprehensive review." she said.

All military services are providing input to the DOD review, officials said. If any changes are made to the tuition assistance policy, they will be instituted in a deliberate, thoughtful manner maintain the integrity of a joint uniform policy for all service members.

Tuition assistance is a popular benefit for military members, particularly in light of the rising costs of post-secondary education courses. However, due to current fiscal constraints, the services consider these costs unsustainable, officials said. Even if adjustments are made to the program, they emphasized that the department will continue to support its members' higher education goals.

"Opportunities for personal and professional growth have long been a part of military life, and the Department of Defense is committed to helping service members pursue civilian education while in uniform," said Robert L. Gordon III, the deputy assistant secretary of defense for military community and family policy.

Among educational offerings at military installations is access to education counselors who provide face-to-face guidance to service members and their families, officials said.

In addition, the Voluntary Education Program portal addresses a full range of educational issues from tuition assistance and financial aid to information on more than 1,800 colleges and universities. The portal may be found at http://apps.mhf.dod.mil/voled.

DOD's off-duty, voluntary education programs represent one of the world's largest continuing education programs, officials said. About 300,000 service members enroll in post-secondary courses each year, leading to associate, bachelor's, master's, and doctorate degrees.

Colleges and universities deliver classroom instruction through an extensive network to hundreds of military installations around the world. ❖
