Subj: CONTROL OF ALCOHOLIC BEVERAGES

Ref: (a) OPNAVINST 1700.16A

1. Purpose. As per reference (a), to publish, in a consolidated form, various orders to personnel regarding the distribution, possession and use of alcoholic beverages and to establish mandatory punitive regulations concerning the same onboard Naval Air Station (NAS) Lemoore.

2. Cancellation. NASLEMINST 1700.3E

3. Scope. This instruction applies to and governs all persons onboard NAS Lemoore.

4. Definition. The term "alcoholic beverage" includes wines, distilled spirits and malt beverages, including beer.

5. Sale and consumption of alcoholic beverages by the drink.

a. Sale and consumption of wines and distilled spirits by the drink are authorized in the following activities.

(1) Spuds Restaurant and Brew Pub.

(2) Officers' Club.

(3) The NAS Lemoore Conference, Catering and Training Center.

(4) Tailhook Lanes Bar (Bowling Alley).

(5) Navy Lodge.

b. Sale and consumption of malt beverages by the drink are authorized in the following activities:

- (1) Spuds Restaurant and Brew Pub.
- (2) Officers' Club.
- (3) The NAS Lemoore Conference, Catering and Training Center.
- (4) Tailhook Lanes Bar (Bowling Alley).
- (5) Tailhook Lanes Snack Bar (Bowling Alley).
- (6) Navy Lodge.
- (7) Concessions operated by the Navy Exchange following paragraphs (5g) and (6) of this section.

c. Commanding Officers of tenant commands are authorized to designate an area in their assigned spaces as an Officers' Mess. The sale and consumption of wines, malt beverages and distilled spirits by the drink are authorized within the command's Officers' Mess provided the following conditions are met:

(1) Commanding Officers must designate a distinct area within their spaces as the Officers' Mess and provide written notice of this action to the NAS Lemoore Commanding Officer (CO). See Enclosure (1).

(2) No permanent or structural changes may be made to the tenant command's assigned spaces to create an Officers' Mess without consent of the base CO and Public Works Officer.

(3) The tenant CO will assume responsibility for the responsible consumption of alcoholic beverages within their Officers' Mess.

d. Activities authorized to sell alcoholic beverages by this section will not sell alcoholic beverages to any person under 21 years of age. Patrons must show identification proving to the satisfaction of the seller of the alcoholic beverage that the patron meets the age requirement for sale.

e. All activities authorized to sell alcoholic beverages by this section will post in a conspicuous place the following notice: **"NOTICE - ALCOHOLIC BEVERAGES PURCHASED HERE MUST BE CONSUMED ON THE PREMISES. NASLEMINST 1700.3F."**

f. Wines and distilled spirits at the Navy Lodge and Bachelor Officers' Quarters will be sold only in miniature-sized containers for on-premise consumption in rooms or suites.

g. The Navy Exchange may sell malt beverages, wines and wine coolers at concessions set up to service special events. Beverages, wines and wine coolers will be sold in single serving containers to be consumed on the premises of the special event.

h. Morale, Welfare and Recreation Department may sell malt beverages and wine coolers at concessions set up in support of special events and ongoing programs. Beverages will be sold in single serving containers to be consumed on the premises of the special event.

6. Sale of alcoholic beverages is authorized for the following activities:

- a. Navy Exchange Retail Store.
- b. Jet Mart.
- c. Q-Mart.
- d. Operations-Side Service Station.

(1) Activities authorized to sell packaged alcoholic beverages by this section will not sell alcoholic beverages to any person under the age of 21 years or on the Alcohol Barment List. Patrons will be required to show a military ID card proving that the patron meets the minimum age requirement. Any agent or employee of an activity authorized to sell packaged alcoholic beverages by this section will refuse to sell alcoholic beverages to any person who is unable to produce adequate evidence that he or she is 21 years of age or older.

7. Possession and consumption in quarters. The possession and consumption of alcoholic beverages in quarters on station are authorized only for persons at least 21 years of age or older.

8. Punitive regulations. This instruction has the full force and effect of a punitive order, and applies without further implementation. Penalties for its violation include the full range of statutory and regulatory sanctions, including the Uniform Code of Military Justice. A failure to comply with provisions of this instruction subjects the individuals involved,

whether civilian or military, to disciplinary and/or administrative action.

a. No person shall sell, furnish or give to any person who is under 21 years of age, alcoholic beverages of any kind.

b. No person, who is under the age of 21 years, shall consume or have in his possession any bottle, can, glass or other receptacle, containing any alcoholic beverages which has been opened, or a seal broken, or the contents of which have been partially removed.

c. No person shall leave any facility at NAS Lemoore which dispenses, serves or sells any alcoholic beverages with any bottle, can or other receptacle containing any beverage which has been opened or a seal broken or the contents of which have been partially removed.

d. No person shall drink any alcoholic beverage or have in their possession while in a motor vehicle upon any road, street, parking lot, driveway or any other land intended or used for transportation or storage of motor vehicles at NAS Lemoore, any bottle, can or other receptacle, containing any alcoholic beverage which has been opened or seal broken or the contents of which have been partially removed. This section shall not apply to the living quarters of a motor home or camper when said vehicle is not being operated.

e. No person, who is the registered owner of a motor vehicle, or the driver, if the registered owner is not present in the vehicle, shall keep in a motor vehicle, while said vehicle is upon any road, street, parking lot, driveway or any other land intended or used for transportation or storage of motor vehicles at NAS Lemoore, any bottle, can or other receptacle containing any alcohol beverage which has been opened or a seal broken, or the contents of which have been partially removed, unless such container is kept in the trunk of the vehicle or kept in some other area of the vehicle not normally occupied by the driver or passengers. This section shall not apply to the living quarters of a motor home or camper.
