- 1. Purpose. To set forth policy and procedures for the safe receipt, storage, and issue of privately owned weapon(s) for Naval Air Station (NAS) Lemoore security detachment and military personnel residing in installation military housing.
- 2. Cancellation. NASLEMINST 5530.10.
- 3. Scope. The provisions of this instruction are applicable to NAS Lemoore security detachment and military personnel residing in installation military housing. Nothing contained in this instruction shall be construed to cancel or supersede any instruction or directive issued by higher authority.
- 4. <u>Definitions</u>. Per reference (g), the following definitions apply:

- a. Abandoned Weapon. Any weapon left behind or deserted.
- b. Ammunition. Ammunition or cartridge cases, primers, bullets, or propellant powder designed for use in any firearm.
- c. Firearm. Any weapon (including a starter gun) which will, or is designed to, or may readily be converted to expel a projectile by the action of an explosive; the frame or receiver of any such weapon; any firearm muffler or firearm silencer; or any destructive device. Such term does not include an antique firearm.
- d. Antique Firearm. The term "antique firearm" means any firearm (including any firearm with a matchlock, flintlock, percussion cap, or similar type of ignition system) manufactured in or before 1898; or any replica of any firearm if such replica is not designed or redesigned for using rim fire or conventional centerfire fixed ammunition, or uses rim fire or conventional centerfire fixed ammunition which is no longer manufactured in the United States and which is not readily available in the ordinary channels of commercial trade; or any muzzle loading rifle, muzzle loading shotgun, or muzzle loading pistol, which is designed to use black powder, or a black powder substitute, and which cannot use fixed ammunition. For purposes of this subparagraph, the term "antique firearm" shall not include any weapon which incorporates a firearm frame or receiver, any firearm which is converted into a muzzle loading weapon, or any muzzle loading weapon which can be readily converted to fire fixed ammunition by replacing the barrel, bolt, breechblock, or any combination thereof.
- e. Dangerous Weapon. A weapon, device, instrument, material, or substance, animate or inanimate, that is used for, or is readily capable of, causing death or serious bodily injury, except that such term does not include a pocket knife with a blade of less than 2-1/2 inches in length. Dangerous weapons include, but are not limited to, pellet guns, BB guns, paint ball guns, Airsoft-style replica firearms, archery equipment, crossbows, or tactical blade-type weapons (knives greater than 2-1/2 inches, swords, machetes, etc.). Navy and Marine Corps ceremonial swords and sabers will not be considered dangerous weapons.
- f. Handgun. A firearm which has a short stock and is designed to be held and fired by the use of a single hand and any combination of parts from which the before mentioned firearm can be assembled.
- g. Rifle. A weapon designed or redesigned, made or remade, and intended to be fired from the shoulder and designed or redesigned and made or remade to use the energy of an explosive to fire only a single projectile through a rifled bore for each single pull of the trigger.
- h. Shotgun. A weapon designed or redesigned, made or remade, and intended to be fired from the shoulder and designed or redesigned and made or remade to use the energy of an explosive to fire through a smooth bore either a number of ball shot or a single projectile for each single pull of the trigger.

i. Locked Container. A storage container that is fully enclosed and locked by a padlock, key lock, combination lock, or similar locking device. The term "locked container" does not include the utility or glove compartment of a motor vehicle.

5. Other applicable definitions

- a. Personal Weapon. A personal weapon is, but not limited to, handguns, long guns, or other guns such as pellet, BB guns and/or any weapon, which launches a projectile via explosive or compressed means/processes, which can kill, injure, or maim to include a crossbow, compound bow or bow and arrow.
- b. Personal Ammunition. Ammunition that does not belong to the Department of Defense (DoD) and was purchased or received from a private or public retailer.
- c. On-installation Military Housing. On installation military housing is any building located in the residential districts of NAS Lemoore that is accompanied by military personnel. On-installation military housing does not include single sailor unaccompanied housing and/or Geographical Bachelor quarters to include Navy Gateway Inns and Suites and Navy Lodge.
- 6. <u>Background</u>. Per references (a) through (c), unless otherwise authorized by applicable law or regulation, personal firearms shall not be possessed, used, introduced, transported, or stored onboard a Navy installation, to include a joint base where the Navy is the lead service, Navy Lodging, unaccompanied housing, and on-base military housing areas without first obtaining prior written approval of the installation Commanding Officer (ICO). The provisions of this instruction do not apply to personnel residing in off-base housing unless otherwise prohibited or regulated by rental/lease agreements, etc. Privately owned weapons are not authorized in unaccompanied housing, Navy Lodge or Navy Gateway Inns and Suites onboard NAS Lemoore.

7. Registration

- a. All personal firearms and dangerous weapon(s) brought onboard NAS Lemoore must be registered with the installation security detachment for storage on-installation or in their residence. Personal firearms and dangerous weapon(s) that are brought onboard NAS Lemoore that are not authorized to be registered and stored on-installation will be considered contraband and be dealt with in accordance with (IAW) reference (i).
- b. Personnel may obtain approval request forms, enclosure (l), for storage of personal firearms in on-installation military housing or building 440 vault by contacting the NAS Lemoore security detachment in building 782 or Weapons representatives in building 441. Requests must be submitted within 14 business days of the personal weapon(s) being accepted.

Personnel on official orders must make all requests. If member requires an extension, a special request chit must be submitted to the installation Security Officer (SECO) with information explaining the reason for the extension.

- c. Upon approval, members will receive an Authorization Letter, enclosure (4), signed by the ICO or other authorized designated representative authorizing storage of personal firearms and/or dangerous weapon(s) in the installation vault or on-installation military housing.
- d. When owners permanently depart the installation on Permanent Change of Station orders or separation/retirement orders, all registered personal firearms and dangerous weapons stored in on-installation military housing or in the installation vault must be administratively deregistered at Pass and ID.

e. Personal Firearms

- (1) Personal firearms may be authorized for storage in the installation vault or oninstallation military housing as long as they are stored and transported IAW California state laws and this instruction. At no time shall personal firearms be carried openly, displayed, or brandished onboard a Navy installation.
- (2) Personal firearms can be temporarily stored in the installation Ready-For-Issue (RFI) but must be collected by a Weapons representative the next business day and also if brought on the installation outside of normal working hours Monday-Friday (0730-1600), on holidays, and during the weekend.
- (3) As part of the registration process the individual must digitally, with the exception of signatures, complete enclosures (1) through (4). Once completed, the registrant will submit the request to the ICO via their chain of command and the NAS Lemoore SECO. Failure to comply with submitting all requirements will result in denial of the request.
 - (4) Personal ammunition will not be stored in the installation vault/RFI.
- (5) Civilian Federal law enforcement personnel entering the installation on official business may carry their assigned firearm.

f. Personal Dangerous Weapons

(1) Personal dangerous weapons may be authorized for storage in on-installation military housing as long as they are stored in a locked container and transported IAW this instruction. Navy and Marine Corps ceremonial swords and sabers are exempt from registration. At no time shall personal dangerous weapons be carried openly, displayed, or brandished onboard a Navy installation.

(2) The registration process for personal dangerous weapon(s) is identical to that of personal firearms.

8. Transportation

- a. The term "transportation" references any movement of a firearm or dangerous weapon, whether visible or non-visible, and includes hand carrying or movement by any form of mechanized transportation.
- b. Per references (c) and (g), firearms will be unloaded and transported in the trunk of the vehicle. If the vehicle has no trunk, they must be transported in locked containers. Rifles and shotguns are not required to be transported in locked containers however, they must be unloaded while being transported.
- (1) In all cases, individuals will comply with all federal, state, and local laws and regulations concerning the transportation of firearms and/or dangerous weapons to and from NAS Lemoore.
- (2) Owners shall hand carry signed copies of enclosure (4) with their firearm(s) and/or dangerous weapon(s) during transportation.
- c. Upon entering the installation, the registered owner shall declare their weapon(s) and its/their location to the sentry. Signed copies of enclosure (4) shall be surrendered upon the sentry's request for verification.

9. Open-Carry/Concealed-Carry

- a. Per reference (c), except as may be necessary in the proper performance of his or her duties or as may be authorized by proper authority, no person shall:
- (1) Have concealed about his or her person any dangerous weapon, instrument or device, or any highly explosive article or compound; or
- (2) Have in his or her possession any dangerous weapon, instrument or device or any highly explosive article or compound onboard any aircraft, or in any vehicle of the naval service or within any installation or other place under naval jurisdiction.

10. Storage

a. Storage of personal firearms and dangerous weapons in locations other than the installation vault are not authorized unless approved by the ICO to store in on-installation military housing.

- (1) In all cases, individuals will comply with all federal, state, and local laws and regulations concerning ownership, possession, registration, and use. In addition, the registering official shall conduct a National Crime Information Center background check and appropriate checks to ensure compliance with the Lautenberg Amendment (section 922 of title 18, U.S. Code).
- b. Personal firearms approved for storage in the installation vault will not be stored in the same container or weapons rack with government Ammunition, Arms and Explosives (AA&E).

11. Storage Request Procedures

- a. During normal working hours (0730-1600):
- (1) Upon arrival at NAS Lemoore during above noted times, all personal weapons are to be taken to the installation Pass and ID office at building 716 (located just outside the main gate).
- (2) Personal weapons will remain in the trunk of the owner's vehicle or have a chamber lock in place if the vehicle contains no trunk during the initial inspection for check-in process.
- (3) A NAS Lemoore security patrol unit will be on sight during the personal weapon inspection at Pass and ID and will provide an escort to security building 782 upon confirmation that the personal weapon has passed inspection and is in compliance with California's firearms regulations https://oag.ca.gov/firearms.
- (4) The personal weapon(s) will not be handled until verified clear and safe at security building 782, utilizing the clearing barrel located outside of the RFI. Personal ammunition will be completely separated from the personal weapons at all times.
- <u>NOTE</u>: Personal ammunition will not be stored or accepted by NAS Lemoore security detachment. Personal ammunition is authorized to be stored in on-installation military housing; but is **NOT** authorized to be stored in single sailor unaccompanied housing and/or Geographical Bachelor quarters to include Navy Gateway Inns and Suites and Navy Lodge.
- (5) Pass and ID personnel will issue a copy of the completed Consolidated Law Enforcement Operations Center (CLEOC) inventory sheet to the weapons owner after the weapons have been registered in CLEOC.
- (6) NAS Lemoore security personnel will then escort the owner to the RFI upon arrival. Once the weapons are verified cleared and safe they will be temporarily stored at the RFI and will be transferred to building 440 vault the next normal working day unless permission is granted for extended RFI storage by the SECO.

- (7) The RFI will issue a weapons receipt to the owner for each personal weapon, refer to enclosure (6). Once the weapons receipt is completed, the RFI will turn over the third page (pink sheet) to the owner which they will later use to show as ownership of the personal weapon(s). The RFI will file the other two pages of the receipt.
- (8) A security weapons detachment representative will be notified by the RFI once they have taken custody of the weapon(s) and the owner has been issued the weapons receipt. Once a security weapons detachment representative has collected the personal weapon(s), they will forward all required storage authorization forms to the owner.
- (9) While the weapons are being stored by NAS Lemoore security, the owner will have 14 working days in order to complete all the required storage authorization forms, utilizing enclosures (1) through (4). Failure to complete the forms in allotted time may result in the cancellation of the request for storage of personal weapons in on-installation military housing or in building 440 vault.
- (10) Upon completion of all storage authorization forms, the owner will provide copies of all forms, including a copy of the CLEOC inventory sheet, to a security weapons detachment representative. The Security Weapons Department representative will then review all storage authorization request paperwork and forward to the ICO or other authorized designated representative for approval.
- (11) Security weapons detachment representative will then turn over the personal weapons to the owner. Security weapons detachment representative will file a copy of the completed package.

<u>NOTE</u>: Once the owner has completed the personal weapons storage authorization process with granted approval, they may store additional or new personal weapons in their on-installation military housing, but **MUST** have the weapons registered at the base Pass and ID office first.

b. After normal working hours:

- (1) Upon arrival at NAS Lemoore, owners of personal weapons will disclose to the sentry that they have personal weapons that need to be stored.
- (2) NAS Lemoore security personnel will then escort the owner to security building 782, where the weapons will remain in the owner's vehicle trunk or locked with a chamber lock until NAS Lemoore security personnel verify that the weapons are clear and safe before being temporarily stored in the RFI.

- (3) The security RFI will issue a weapons receipt to the owner for each personal weapon, refer to enclosure (6). Once the weapons receipt is completed, the RFI will turn over the third page (pink sheet) to the owner, which they will later use to show as ownership of the personal weapon(s). The RFI will file the other two pages of the receipt.
- (4) A security weapons detachment representative will then be notified about the storage of the personal weapon(s) by the RFI.
- (5) The RFI will disclose to the owner that they are required to report the next working day during normal working hours to the RFI so they can have their weapon(s) escorted to the Pass and ID office at building 716 to begin the personal weapons storage request process.
- 12. Storage and transportation of approved personal weapons onboard NAS Lemoore and in oninstallation military housing
- a. Owners of personal weapon(s) are ultimately responsible for the safe storage of personal weapon(s) and personal ammunition in their on-installation military housing. Failure to follow proper protocol will result in the revocation of permission to store personal weapon(s) in NAS Lemoore on-installation military housing.
- b. Owners of personal weapon(s) will, at all times, keep a copy of completed personal weapons storage authorization forms, enclosures (1) through (4) and a copy of the stamped CLEOC print out for each personal weapon with the personal weapon(s) whether they are being stored or transported.
- <u>NOTE</u>: If the owner loses their right to store personal weapons in NAS Lemoore on-installation military housing, then NAS Lemoore security personnel will store the personal weapons in building 440 vault until the owner can find off base storage.
- 13. Security Detachment responsibilities of stored personal weapon(s)
- a. NAS Lemoore security weapons detachment personnel are responsible for the transportation of personal weapon(s) from building 782 to building 440.
- b. Personal weapon(s) are not to be stored with DoD AA&E and will be in their own locked safe, weapons locker, or weapons rack.
- c. An inventory record form, enclosure (5) will be completed for each personal weapon(s) stored in building 440 vault.
- d. Upon discovery of any missing personal weapon(s), security weapons detachment personnel will notify the SECO and Naval Criminal Investigative Service (NCIS) immediately.

e. All personal weapons paperwork will be kept on file for a minimum of three years.

14. Abandoned Personal Weapon(s)

- a. After 30 days of the owner of the personal weapon(s) transferring and failing to reclaim their weapon(s), the weapon(s) will then be declared abandoned.
- b. The security weapons detachment personnel will make every effort possible and will document all attempts of contact with the owner in regards to having them reclaim their weapons.
- c. If contact is made with the owner and they wish to reclaim their personal weapon(s), then the security weapons detachment personnel will coordinate with the owner to return their personal weapon(s).
- d. If contact is made with the owner and they do not wish to reclaim their weapon(s), the security weapons detachment personnel will obtain a statement from the owner stating so. All paperwork will then be turned over to NCIS in order to coordinate the turnover of the personal weapon(s).
- e. After three attempts of contact with the owner are made and they fail to respond, then the security weapons detachment personnel will supply NCIS with all forms of paperwork and contact documentation to coordinate the turnover process of the personal weapon(s).

15. Inventory

- a. Inventory of personal firearms and personal dangerous weapons will be conducted semiannually and documented via enclosure (5). Contact will be made annually to verify service member's Projected Rotation Date and/or End of Active Obligated Service.
- b. The security weapons detachment personnel will document on enclosure (6) each time the owner of a personal firearm removes and returns the weapon to storage. Note: Paragraph 8 above applies for transportation.
- c. When personnel permanently depart the installation, all registered personal firearms must be administratively deregistered (placed inactive) in CLEOC by Pass and ID personnel, and the weapon removed from the installation by the owner. If member transfers/leaves without removing weapons, they will be disposed of. This authorization will only come after NAS Lemoore security attempts to contact the service member three times via primary email address and phone number listed in enclosure (3). 14 days after the third attempt to contact the service member, their personal firearm(s) or dangerous weapon(s) will be deemed abandoned and processed for destruction.

- 16. <u>Records Management</u>. Records created as a result of this instruction, regardless of media and format, must be managed per Secretary of the Navy Manual 5210.1 of September 2019.
- 17. Review and Effective Date. Per OPNAVINST 5215.17A the Security Officer will review this instruction annually on the anniversary of its issuance date to ensure applicability, currency, and consistency with Federal, Department of Defense, Secretary of the Navy, and Navy policy and statutory authority using OPNAV 5215/40 Review of Instruction. This instruction will be in effect for 10 years, unless revised or cancelled in the interim, and will be reissued by the 10 year anniversary date if it is still required, unless it meets one of the exceptions in OPNAVINST 5215.17A, paragraph 9. Otherwise, if the instruction is no longer required, it will be processed for cancellation as soon as the need for cancellation is known following the guidance in OPNAV Manual 5215.1 of May 2016.

QUALIFICATION TO POSSESS FIREARMS OR AMMUNITION

PRIVACY ACT STATEMENT

AUTHORITY: 18 U.S.C. 922(g)(9); E.O. 9397.

PRINCIPAL PURPOSE(S): To obtain information to determine if you have been convicted of a crime of domestic violence which would disqualify you from shipping, transporting, possessing or receiving either Government-issued or private firearms or ammunition and to determine if reassignment, reclassification, detail or other administrative action is warranted. Your Social Security Number is solicited solely for purposes of verifying your identity.

ROUTINE USE(S): To the Department of Justice so that such information can be included in the National Instant Criminal Background Check System which may be used by firearm licensees (importers, manufacturers or dealers) to determine whether individuals are qualified to receive or possess firearms and ammunition.

DISCLOSURE: Mandatory for all personnel who are required to certify. Failure to provide the information may result in (1) (military only) the imposition of criminal or administrative penalties for failing to obey a lawful order, and (2) (civilian only) the imposition of administrative penalties, to include removal from Federal service. However, neither your answers nor information or evidence gained by reason of your answers can be used against you in any criminal prosecution for a violation of Title 18, United States Code, Section 922(g)(9), including (military only) prosecutions under the Uniform Code of Military Justice, based on a violation of Section 922(g)(9), for conduct which occurred prior to the completion of this form. The answers you furnish and any information resulting therefrom, however, may be used against you in a criminal or administrative proceedings if you knowingly and willfully provide false statements or information.

SECTION I - INSTRUCTIONS

An amendment to the Gun Control Act of 1968 (18 U.S.C. 922) makes it a felony for anyone who has been convicted of a misdemeanor crime of domestic violence to ship, transport, possess, or receive firearms or ammunition. It is also a felony for any person to sell or otherwise dispose of a firearm to any person so convicted.

The Department of Defense has, by policy, expanded the prohibitions contained in Title 18 Section 922(g)(9) to those military or civilian personnel who have felony convictions for crimes of domestic violence. Convictions of crimes of domestic violence do not include summary court-martial convictions, the imposition of nonjudicial punishment (Article 15, UCMJ), or deferred prosecutions (or similar alternative dispositions) in civilian courts. Furthermore, a person shall not be considered as having committed a "crime of domestic violence" for purposes of the firearms restriction of the Gun Control Act unless all of the following elements are present:

(1) the person was convicted of a crime;

- (2) the offense has as its factual basis the use or attempted use of physical force, or threatened use of a deadly weapon;
- (3) the convicted offender was at the time of the offense:(a) a current or former spouse, parent or guardian of the victim.
 - (b) a person with whom the victim shared a child in common,

- (c) a person who was cohabiting with or has cohabited with the victim as a spouse, parent, or guardian, or
- (d) a person who was similarly situated to a spouse, parent, or guardian of the victim;
- (4) the convicted offender was represented by counsel, or knowingly and intelligently waived the right to counsel;
- (5) if entitled to have the case tried by jury, the case was actually tried by jury or the person knowingly and intelligently waived the right to have the case tried by jury;
- (6) the conviction has not been expunged or set aside, or the convicted offender has not been pardoned for the offense or had civil rights restored, unless the pardon, expungement, or restoration of civil rights provides that the person may not ship, transport, possess or receive firearms.

If you have ever received a domestic violence conviction: (1) you may not possess any firearm or ammunition; and (2) you must return any Government-issued firearm or ammunition to your commander or immediate supervisor; and (3) you must take steps to relinquish possession of any privately owned firearms or ammunition. Furthermore, any previously issued authorization to possess a firearm or ammunition is revoked.

If you have any questions, or you are uncertain if you have such a conviction, you may wish to contact a legal assistance attorney, if eligible, or a private attorney, at your own expense.
